



## 0% Finance Offer

### Terms and Conditions

1. The 0% Interest Free Finance Offer is open only to domestic property owner occupiers (not tenants or landlords) that have never been connected or are not in the process of being connected to the Phoenix Energy network. The registered property will have an existing central heating system fuelled by LPG, oil, solid fuel or electricity (storage heaters).
2. The property owner must install an 'A rated' natural gas condensing boiler, manufactured by Alpha, Baxi, Glow-worm, Ideal, Vaillant or Worcester Bosch, and full controls upgrade, where appropriate.
3. In these conditions, the "Offer" means the 0% Interest Free Finance Offer whereby Phoenix Energy will cover the subsidy costs related to the provision of a Shermin Finance 0% interest free loan up to the value noted below.
4. Phoenix Energy will provide financial support on a Shermin Finance 0% interest free loan up to the value of £3,000.  

Representative example. Cash price £3,000. Total amount of credit £3,000. Interest rate 0% fixed. Pay 36 monthly installments of £83.33, 0% APR Representative. Total amount payable £3,000. Credit arranged by Phoenix Energy Registered Gas Installers who are authorised and regulated by the Financial Conduct Authority to carryout credit broking.
5. Where the cost of installation exceeds the loan amount the customer will be responsible for agreeing payment terms for the remaining balance with their chosen installer.
6. The finance application must be made by the same person that completes the Phoenix Energy Gas Connection Application.
7. The finance application must be submitted noting the connection address as the applicant's primary residence. The only exception is where the applicant has only recently purchased the connecting property and needs to use a previous address for credit checking purposes.
8. To qualify for the Offer claimants must first request their connection to the Phoenix Energy network after 1st March 2026 and before 30<sup>th</sup> June 2026 (subject to availability).
9. Verbal or written connection requests to Phoenix Energy submitted before 1<sup>st</sup> February 2026 will invalidate this offer even if the physical connection appointment has been subsequently cancelled or re-arranged by Phoenix Energy or the property owner.
10. The property connection must be completed within 28 days of the first request date.
11. The 0% interest free finance offer can be used with the Free Connection to the natural gas meter offer and the Phoenix Energy Boiler Replacement Allowance Offer.

  - Government funded central heating grants (including; The NI Sustainable Energy Programme (NISEP) and Affordable Warmth)

Property owners will only be able to avail of the 0% Interest Free Finance offer if they employ a Gas Safe registered company (installer) who is registered with Phoenix Energy to offer this incentive. The installer must undertake the full installation of the heating system including the provision of all relevant materials.
