



## Phoenix Community Fund Terms and Conditions

1. Applicants must be over 18 years old.
2. Applicants must demonstrate how they are affiliated with the group.
3. Applications must come from groups based that are situated in the Phoenix Licensed Area of Greater Belfast or East Down.
4. Applicants who are successfully awarded funding may only submit one application within a two-year funding period. Individuals who apply in one funding year will not be eligible to apply in the immediately following funding year.
5. All funds received from the Phoenix Community Fund must be used in Northern Ireland
6. A max of £500 will be awarded and the total cost of the project must not exceed £1000.
7. Applicants must not have established funding streams/ regular funders
8. Groups from all sectors are welcome to enter.
9. All funds received must be used to support the delivery of an event or activity which is inclusive and open to a cross section of the community.
10. All funds from Phoenix Energy must be made out to a registered bank account in the community group / organisations name.
11. Events and activities must be scheduled to take place between 1<sup>st</sup> April 2025 – 1<sup>st</sup> March 2026, any decision to reschedule the event or activity outside these dates must be agreed in advance with Phoenix Energy.
12. As part of the fund, you will be asked to consent and facilitate PR & media opportunities including but not limited to social media, photo appearance and a representative of Phoenix on the day of the event.
13. Phoenix Energy staff members are exempt from directly applying for the fund.
14. Recipient(s) are selected by a judging panel and judge's decision is final.
15. Phoenix Energy excludes liability, to the fullest extent permitted by law, for any loss, damage or problem caused to any organisation arising out of any funding provided
16. The Phoenix Community Fund may be subject to additional terms and conditions and the recipient(s) is responsible for ensuring that any such terms and conditions are complied with (and shall bear the cost of such compliance).
17. By applying to the Phoenix Community Fund, the entrant agrees to warrant all information submitted by it as true, current, and complete.
18. The entrant agrees to completing a feedback survey post event sent via email.
19. Phoenix Energy reserves the right to cancel or amend the Fund or these Terms & Conditions at any time without prior notice.
20. Phoenix Energy assumes that by applying to the Fund, the entrant warrants that it has legal capacity to apply for funding and agrees to these Terms & Conditions.
21. If there is any dispute regarding these Terms & Conditions, conduct, results, and all other matters relating to the competition, the decision of Phoenix Energy shall be final, and no correspondence or discussion shall be entered into with any entrant.
